An Audit Committee meeting of the Board of Trustees of the Contra Costa Mosquito and Vector Control District was held on Thursday, January 12, 2023, via teleconference pursuant to Governor's Executive Orders N-25-20, N-29-20, and N-33-20 and the Contra Costa County Public Health Officer Order No. HO-COVID19-03, and guidance from the CDC to minimize the spread of the coronavirus.

- 4. <u>APPROVAL OF MINUTES FROM AUDIT COMMITTEE SPECIAL MEETING HELD ON JUNE 14, 2022</u>
- \*\* Motion was made by Trustee Krieg and seconded by Trustee Carlton to approve the minutes from the Audit Committee special meeting held on June 14, 2022. *Motion passed unanimously*.
- 5. MET WITH DISTRICT AUDITORS, MAZE & ASSOCIATES, FOR REPORT AND ANALYSIS OF DRAFT OF FY22 (2021-2022) DISTRICT AUDIT AND MEMORANDUM OF INTERNAL CONTROL STRUCTURE the committee reviewed and discussed the draft audit document provided by David Alvey. Alvey stated that the audit was free from material misstatements and accurate, and that the District was receiving an unmodified opinion again. He explained that the District total current assets increased 8.3%, which was mostly due to property tax increases. Alvey also answered

questions from the committee regarding GASB 87 and the lease of the Brentwood facility, and pension liability and net pension asset. The committee unanimously agreed to recommend the audit for Board approval at the following Board meeting.
