# 4. <u>APPROVAL OF MINUTES FROM PERSONNEL COMMITTEE MEETING HELD</u> <u>ON APRIL 11, 2011</u>

A motion was made by Trustee Pellegrini to approve minutes from the Personnel Committee Meeting held on April 11, 2011, seconded by Trustee Mank. *Motion passed*.

- 5. <u>REPORT ON EMPLOYEE HANDBOOK</u> General Manager Craig Downs reported that there were no recommended changes to the Employee Handbook this year.
- 6. <u>EMPLOYEE BENEFITS COMPARISON (Appendices I & II</u>) General Manager Craig Downs reviewed the chart comparing benefits offered the District's employees compared to benefits offered in five local cities and five local special districts. District offered benefits were similar to the ten agencies reviewed. Trends in the five cities included capping employer contributions for health plans (require future increases be paid by the employee) and to look at increasing employee contribution rates to pension plans. It was noted that district employees currently have the highest contribution rate compared to the

ten agencies. District employee contribution rates range from 2.49-4.44%, while the range for the ten agencies surveyed were 0-2%.

7. <u>SALARY REVIEWS</u> - The Committee reviewed the salary ranges for the positions; Operations Manager, Program Supervisor and Community Affairs Representative and recommend no changes to any of the ranges. The committee directed the General Manager to include the Community Affairs Representative position in next years reviews.
