- 7. TRUSTEE MANUAL The Trustee Manual revision was initiated in 2019 by the Ad Hoc Trustee Manual Committee. The last meeting date for that committee was in September of 2019. The committee did not meet in 2020 or 2021 because of the added workload on staff due to the COVID-19 pandemic. The committee will discuss a new timeline for the Trustee Manual and committee composition.
