- 1. Vice President Bana called the meeting to order at 7:05 p.m.
- 2. A roll call indicated that 15 Trustees were present, 5 were absent, and there were two vacancies.

- 3. The meeting opened with the Pledge of Allegiance.
- 4. APPROVAL OF AGENDA AS POSTED
- ** A motion was made by Trustee Pinckney and seconded by Trustee Pellegrini to approve the Agenda as posted. *Motion passed unanimously*.

5. PUBLIC INPUT ON NON AGENDA ITEMS

David Wexler, Vector Control Inspector and Shop Steward, introduced himself to the Board and requested a survey be conducted by a third party to measure employee morale.

6. CONSENT CALENDAR

- ** A motion was made by Trustee Pellegrini and seconded by Trustee Pinckney to approve items 6A through 6E of the consent calendar. *Motion passed unanimously*.
 - F. <u>APPROVAL OF TRUSTEE TRAVEL</u> Trustee Belleci is requesting reimbursement of expenses for travel to the California Special Districts Association Annual Conference in Monterey, CA, October 10-13, 2011.

Item pulled for discussion.

** A motion was made by Trustee Fitzsimmons and seconded by Trustee Pellegrini to deny travel reimbursement for Trustee Belleci. *Motion passed*.

7. ACTION ITEMS

A. Report on Mosquito & Vector Surveillance and Control Engineers Report on the District-Wide Special Benefit Assessment

Jennifer White, of Francisco & Associates, gave an overview of the Engineers report for Fiscal Year 2011/2012. Ms. White explained the benefit assessment units, benefit criteria and methodology used to develop the District's Benefit

Assessment. Ms. White detailed the steps necessary for the different types of parcels and zones in Contra Costa County.

- ** A motion was made by Trustee Pellegrini and seconded by Trustee Head to approve the Engineers Report for Contra Costa Mosquito and Vector Control District Benefit Assessment - Fiscal Year 2011/2012. *Motion passed unanimously*.
- ** A motion was made by Trustee Pellegrini and seconded by Trustee Cowen to adopt Resolution 11-2, to continue the Mosquito & Vector Surveillance and Control Project for the benefit of four zones and to continue the financing of the Project by continued assessment upon property within the District. *Motion passed unanimously*.
 - B. Personnel Committee Report General Manager Downs reported that the Personnel Committee met on June 6, 2011. The committee had no recommended changes to the employee handbook. As for the review of salary ranges for three job classifications, the committee felt they were well within market and no adjustments were warranted. They also recommended there be no across the board COLA increase for unrepresented employees.
 - C. <u>Budget Committee Report</u> Trustee Bana and Administrative & Finance Manager Waletzko reported that the Budget Committee met on June 20, 2011. The FY 11/12 budget is proposed with a projected \$235,000 deficit due to continued reduction in property tax revenue. General Manager Downs answered questions regarding the Mosquito Research Foundation funding.
- ** A motion was made by Trustee Belleci to reduce the research line item on the proposed budget from \$25,000 to \$5,000. *Motion failed for lack of a second.*
- ** A motion was made by Trustee Fitzsimmons and seconded by Trustee Bana to approve the Proposed Budget for FY 2011/2012. *Motion passed.*

The full Board of Trustees is required to annually adopt the District Investment Policy. The committee reviewed the current policy and there were no changes from last year.

- ** A motion was made by Trustee Saavedra and seconded by Trustee Brownfield to adopt the District Investment Policy. *Motion passed unanimously*.
 - D. Advanced Planning Committee Report Trustee Brownfield reported that the committee met several times this year to discuss the Five Year Plan 2011-2015. The committee took a very conservative approach to the plan; with no planned growth at this time. The goal of the plan is to prioritize the Districts mission, keep high quality programs and maintain current staffing levels.
- ** A motion was made by Trustee Head and seconded by Trustee Petreas to adopt the Five Year Plan 2011-2015. *Motion passed unanimously.*
 - E. <u>Mosquito & Vector Control Association of CA</u> General Manager Downs discussed his nomination by the costal region for candidacy of Vice President to the MVCAC Board of Directors. If elected he would serve as Vice President in

- ** A motion was made by Trustee Belleci to deny the Nomination of General Manager Downs to run for Vice President to the MVCAC Board of Directors. Motion failed for lack of a second.
- ** A motion was made by Trustee Fitzsimmons and seconded by Trustee Micheals to Ratify the Nomination of General Manager Downs to run for Vice President to the MVCAC Board of Directors. *Motion passed*.

8. INFORMATION ITEMS

- A. <u>West Nile Virus Update</u> General Manager Downs reported to date, there has been one positive bird reported in Contra Costa County. Statewide, virus transmission has been low; WNV has been reported in 12 counties, 37 birds from 9 counties and 31 mosquito samples from 7 counties have tested positive for the virus. No human, horse, squirrel or sentinel chicken cases have been reported this year.
- B. <u>Legislative/Regulatory Report</u> General Manager Downs reported on the impending NPDES Permit. Federal legislation H.R.872 was discussed, it states the Clean Water Act does not have jurisdiction over FIFRA, FIFRA EPA would continue to be the authority over pesticide regulation. If passed, the NPDES permit would not be required to apply adulticides.
