- 1. President Wolcott called the meeting to order at 7:01 p.m.
- 2. A roll call indicated that 18 Trustees were present, four were absent, and there are no vacancies.

President Wolcott introduced Brian Smalley, new Trustee from San Pablo and Kirk Thill, new Trustee from Brentwood.

3. The meeting opened with the Pledge of Allegiance.

4. APPROVAL OF THE AGENDA

8. INFORMATIONAL REPORTS

A. <u>Executive Committee Report</u> - Diane Wolcott, Chair of the Executive Committee, reported that the committee met on February 17, 2009. Items discussed included; the District's GASB 45 actuarial valuation of other post-employment benefit programs was completed; a joint report from the MVCAC and VCJPA titled "Mosquito and Vector Control District Trustees as District Employees?"; a recent 6th Circuit Court of Appeals decision concerning the NPDES permitting

process; and state budget issues and their effect on District revenues. The committee will bring to the full board at a later date a few of these items once they have recommendations.

- B. <u>Personnel Committee Report</u> Jose Saavedra, Chair of the Personnel Committee, reported that the committee met on February 23, 2009. Items discussed included; the process and review for personnel and salaries & benefit adjustments; Five Year Plan staffing; Employee Handbook policy changes; and ongoing negotiations with SEIU Local 1021. The committee will have recommendations at the July board meeting regarding unrepresented employees and recommendations at a future meeting regarding represented employees pending conclusion of negotiations.
- C. Fish Program - Biologist Chris Miller presented the 2009 Fisheries Program Update. The presentation covered the Districts mosquitofish culture methods and mosquitofish production numbers. The recent increase in mosquitofish distribution was caused by the increase in non-maintained pools (increase in foreclosed homes). Research on Sacramento perch as a biological agent of mosquitoes was presented. While Sacramento perch did show some promise. production challenges as well as the failure of perch to survive in waters that contained non-native centrarchids (bass, bluegill & crappie) has made operational use impractical. Use and research on this species will be done on a limited basis in the future. Highlights of this research was the publication of two papers in scientific journals and the discovery of an attachment filament in prolarvae that was not previously documented (paper in progress). Outside grants obtained by Biologist Miller for research on Sacramento perch total \$34,000 for 2006 to 2008. The final part of the presentation was an overview of California native fish species that are candidates for future biological control research and include California roach (Lavinia symmetricus), Hitch (Lavinia exilicauda) and Sacramento blackfish (Orthodon microlepidotus).
- D. <u>Report on Annual Environmental Audit/ CEQA Compliance (Appendix I)</u> -Environmental Projects Manager Karl Malamud-Roam presented the Annual Environmental Audit and CEQA Review. In particular, he reported in detail on the District's use of fish and pesticides, and how these use patterns compared with previous years. Some minor variations are observed from year to year, largely as a result of weather influences and other impacts on mosquito habitat distribution, but no major changes in District policies nor practices were noted. A review of changing regulatory requirements and recent scientific studies on the potential environmental impacts of vector control practices was presented.
- E. <u>West Nile Virus Update</u> General Manager Downs reported, to date, there have been 4 dead birds detected, all in Southern California. 2 birds reported from San Diego & Orange Counties as well as 2 chickens converting from a flock in Los Angeles County. District seasonal Vector Control Aides have returned and their focus will be neglected swimming pools. This allows Vector Control Technicians to focus on other sources throughout the county.
- F. <u>Self Insurance Programs VCJPA (Appendix II)</u> General Manager Downs summarized important points of the recent audit of the Vector Control Joint Powers Agency. He explained that the various insurance coverage programs offered to the member districts are purchased, partially self insured or fully self

insured; which is determined by a majority of the members. Fiscal year highlights include Assets of \$11.5 million while Liabilities amount to \$6.1 million. Financial stability of the VCJPA is sound and the program is considered very successful based on a number of criteria.

G. <u>Conferences Attended (Appendix III)</u> - Trustees Russ Belleci, Richard Means and Diane Wolcott each submitted a summary on the MVCAC Annual Conference.
