7. ACTION ITEMS

A. <u>Report on District Annual Audit (Appendix I)</u> - Ms. Vikki Rodriguez, Maze & Associates, stated that the District received an unqualified opinion on the financial audit; which is the highest rating available. The Memorandum on Internal Control Structure was reviewed and no material weaknesses were found; deeming the controls adequate. Ms. Rodriguez noted that GASB 54, Fund Balance Reporting and Governmental Fund Type Definitions, was implemented this year. This implementation has consolidated the General, LAIF & VCJPA funds into one fund in the audit. It was noted that the District contributed \$400,000 to the Other Post Employment Benefits (OPEB) trust this year. There were no other major changes to report.

Trustee Rossi reported that the Audit committee met on November 2, 2011, at the offices of Maze & Associates. The committee reviewed the draft of the financial audit and the memorandum of internal control, and discussed the initial funding of OPEB Trust. Due to the increased risk of cyber attacks, the District IT controls were tested as part of the audit process. There were no material weaknesses or significant deficiencies found.

** Motion was made by Trustee Head and seconded by Trustee Rossi, to accept the District Annual Audit and Memorandum on Internal Control Structure from the auditing firm of Maze & Associates. *Motion passed unanimously.*

8. INFORMATIONAL REPORTS

A. <u>West Nile Virus Update</u> - Steve Schutz, Scientific Program Manager, reported that West Nile Virus (WNV) activity this season has been comparable to that of previous seasons. Activity was delayed this season due to cooler temperatures. The first positive bird was reported in late June, mosquito sample in August and the first human case was reported in September. Final Contra Costa County numbers for the 2011 season are as follows: 43 WNV positive birds, 7 positive mosquito samples, 3 human cases and no positive chicken or horse cases.

Scientific Program Manager Schutz also summarized the Society for Vector Ecology conference that he attended in Flagstaff, AZ. This particular conference focused on all disease vectors and was research and academic oriented.

- B. <u>Public Affairs Report</u> Deborah Bass, Public Affairs Manager, provided an overview of the public affairs department's strategies and outreach efforts for 2011. With scrutiny on public agencies it is crucial for our District to, as we always have, remain transparent and stay true to our mission to protect public health. The public affairs department continued to educate the public on why mosquito control matters and the services we provide to protect them from emerging diseases. Along with the regular newspaper and Pennysaver advertisements, a new tactic was used this year in the form of ads on BART platforms and the tail end of buses within the county. Another important method of communication has been Social media, specifically Twitter; which allows the District to get our message out immediately. News organizations and blogs who follow us re-post our message which then reaches a wide array of constituents. The public affairs department will continue to monitor the pulse of the community, prepare effective communication and uphold the Districts reputation.
- C. <u>Regulatory Update</u> General Manager Downs reported on the progress of the NPDES Permit, which is now in effect. The District will continue to work with the NPDES Permit Coalition on the toxicity and physical monitoring requirements of the permit.
- D. <u>Reports on Conferences/Meetings Attended</u> General Manager Downs reported on the Vector Control Joint Powers Association (VCJPA) and Mosquito and

Vector Control Association of California (MVCAC) fall meetings. General Manager Downs reported he was elected vice president of MVCAC for 2012. MVCAC has been working on the compliance with the NPDES permit as well as discussing updating CEQA documentation.

9. BOARD AND STAFF ANNOUNCEMENTS

- A. Board Trustee Bennett reported that the Personnel Committee met on October 17, 2011. All committee members were present as well as David Wexler, Shop Steward; Keith Snodgrass, SEIU 1021 Representative; and Fran Buchanan, IEDA. Specific concerns were discussed and it was determined that General Manager Downs should handle all personnel issues. It was advised that all employees attend mandatory team building training.
- B. Staff General Manager Downs reminded trustees that a 2012 meeting calendar will be distributed prior to the January Board meeting. It will include MVCAC, CSDA & AMCA conference dates.

There being no further business, the meeting was adjourned at 8:37 p.m.
