- 5. <u>MEET WITH DISTRICT AUDITORS TO REVIEW FISCAL YEAR 07/08 ANNUAL</u> <u>AUDIT PROCESS</u> - Vikki Rodriguez from Maze & Associates started the meeting with a handout that detailed the steps their firm would follow in auditing the District financial statements for fiscal year 07/08. Ms. Rodriguez noted that Statement on Accounting Standards 114 requires that some party from the entity have a discussion with the auditors regarding planning, process, scope, timelines and fraud. The District Audit Committee qualifies as that entity.

The District compliance with GASB 45, post retirement benefit costs, was discussed and Administrative & Finance Manager Waletzko stated that the actuarial study is in progress and the District anticipates compliance before the required deadline.

The committee requested the auditors include a statement in the audit to the effect that the District information technology security was sound. Ms Rodriguez assured everyone that

Maze & Associates does audit those functions and they will include a statement as such in the final audit.

It was noted that the auditors would be at the District offices September 15^{th} - 18^{th} , 2008 for their field work.
